In continuation to the reference 3<sup>rd</sup> and 4<sup>th</sup> cited above, the Principals & Managements of all Engineering Colleges are informed not to collect any sort of fees from the students getting admission into Engineering Colleges through 7.5 percent Special Internal Allocation. In spite of our communication, the Directorate is getting complaints that some Colleges are insisting on payment of fees from students and also insisting the students to produce Bonafide certificate from their school.

In this regard, the Principal & Management of all Engineering Colleges are once again reiterated not to collect any sort of fees and not to insist the students to produce

Bonafide certificate from their school. For those Government school students who are selected through 7.5 percent Special Internal Allocation, in the TNEA 2021 Provisional allotment order, it is clearly mentioned as SPL-GOVT in the Admission Number and (GS) in the Quota allotted. Hence there is no need to get the Bonafide certificate from the students, as the verification has been done by the Tamil Nadu School Education Department.

**Instead the Principal / Management of Engineering Colleges are requested to collect a Self Declaration form duly signed by the student and Parent/ Guardian from the TamilNadu Government school students who are selected through 7.5 % Special Internal Allocation at the time of admission.** The prescribed format of the Self Declaration form is enclosed herewith for your kind information.

It is also informed that all the candidates who are allotted under Single Window counseling of TNEA 2021 can report for admission to the college on or before **25.10.2021**.
